## Commercial Features

- DirecTV DRE IR pass-through** ..... Allows the TV to pass commands from the TV remote to the DirecTV box.

- Auto Power On** ..... Selectable power state of the TV after a power cycle.
- Auto Power Off** ..... Allows the TV to turn off after a selectable period of inactivity.
- Master & Guest Remotes**..... Separate remotes for configuration and operation.
- Bed 1/2/3 Capable**..... Allows simultaneous control of multiple TVs in the same room.
- Front Panel/Menu Lockout** ..... Allows facility to disable front panel and menu controls to make television "tamper proof".
- Splash Screen**..... Ability to add facility logo to startup screen using a JPG file and USB.
- Control Port** ..... RS-232C allows for integration with "infotainment" providers and video conferencing equipment.

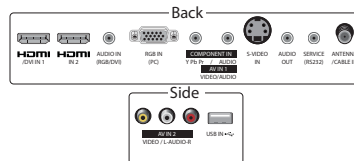
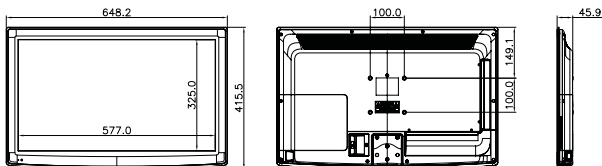
